# PROPOSALS FOR PRIMARY SCHOOL P1 NUMBERS AND SECONDARY SCHOOL S1 NUMBERS FOR SESSION 2024/25

Purpose of Report:  This report seeks approval from the City Administration Committee to apply P1
capping limits in primary schools (P1 numbers) and S1 capping limits for secondary schools (S1 numbers) for session 2024/25.
Recommendations:
The Committee is asked to:
Approve the maximum P1 intakes in primary schools as noted in Appendix 1 for session 2024/25.
Approve the S1 maximum intakes in secondary schools as noted in Appendix 2 for session 2024/25.
Authorise the Executive Director of Education to amend the P1 and S1 capping limits in the circumstances outlined in paragraphs 4.5, 4.6 and 4.7 and 4.12.

#### 1 BACKGROUND

- 1.1 In response to the predicted changes in the school age population across the city over the coming decade and beyond, there is a need to manage the education estate effectively at both strategic and operational levels to ensure that there is adequate capacity to meet the changing demand for places in the city's primary and secondary schools.
- 1.2 The primary age population has been increasing over the last ten years, although now forecast to reduce over the next decade, the previous primary roll increase is now leading to increasing Secondary school rolls.
- 1.3 In order to manage the education estate effectively, the following factors need to be taken into account:
  - The current capacities of the city's primary and secondary schools
  - The forecast demand for catchment area places over the coming years based on birth rates, inward/outward migration and planned housing developments
  - The current and predicted pattern of placing requests, into and out-with the city and between schools within the city boundaries
- 1.4 In October 2014 the Scottish Government issued national guidance on determining the capacity of primary schools. In doing so, this ensures a consistency and transparency of practice that aims to protect, as far as possible, flexibility to adopt a variety of learning and teaching styles in line with the expectations of a "Curriculum for Excellence".
- 1.5 The national guidance has been used to re-determine the capacities of the Council's primary schools and their maximum P1 intakes. Details of the redetermined P1 maximum intakes for all primary schools are contained in Appendix 1.

#### 2. Operational Management of the Education Estate

- 2.1 At an operational level the Council is required to plan for the sufficiency of primary and secondary school places across the city on a rolling annual basis with priority given to children and young people residing within the defined catchment areas. Having ensured that catchment area needs can be met, then placing requests are approved in line with legislation and the Council's placing request priority criteria.
- 2.2 In 2014/15 the Council took the decision to use the provisions within the placing request legislation to reserve places for catchment area children and young people where there was a demonstrable need due to enrolment patterns beyond the normal enrolment timetable or where there is future demand forecast due to, for example, new housing developments.
- 2.3 This alone, however, will not ensure that adequate capacity is maintained in certain schools across the city due to a range of factors including:

- the overall capacity of the school
- the desire to maintain a level of flexible spaces/rooms to ensure that a range of learning and teaching approaches can be utilised in line with the principles of a Curriculum for Excellence
- the complexities of varying class size maxima that determine class organisation year on year
- the capacity of specialist accommodation in secondary schools, e.g. science, technical and home economics, physical education
- the demand for placing requests
- the general trend of pupil population growth predicted over the medium to long term
- Overseas enrolments

#### 3 ANNUAL SUMMARY OF P1 AND S1 TRANSITIONS FOR AUGUST 2023

3.1.1 A total of 6832 P1 enrolments were processed for start of session in August 23. details in table below:

- 3.1.2 A total of 5829 P7 transitions for S1 in August 2023 were processed.
- 3.1.3 Some schools were unable to accommodate the number of pupils transferring and in these instances an oversubscription or local school full process was require. The key points to note are
  - Oversubscription exercises were required for the Glendale Gaelic, Glasgow Gaelic Primary and Calton Gaelic (NE Annex) schools in January as available places exceeded catchment enrolments. Pupils were placed at alternative GME establishments where possible or their catchment non GME school.
  - Where an increase in capacity is possible without impacting future years intake, then the Head of Service can approve an increase.
    - It was necessary to increase capacity for 5 primary schools to accommodate catchment pupils during the session. However due to subsequent movement only 2 schools (St Monica's Milton and St Monica's) remain above their agreed cap.
    - It was necessary to increase capacity for 4 Secondary schools to accommodate catchment pupils during the session – St Paul's, Bellahouston Academy, Knightswood Secondary and Hillpark Secondary. However due to subsequent movement none were above their agreed cap.by start of session in August.

• At various points during the P1 exercise 23 Primary schools could not accommodate a total of 210 catchment enrolments leading to the Local School Full process being invoked. The majority of these were resolved due to subsequent movement of children across the estate or placing requests granted out with authority. By 31st July only 9 schools (Riverbank PS, St Maria Goretti PS, Glasgow Gaelic School, Gaelic NE Annexe, Glendale GME, Ibrox PS, St Angela's PS, St Francis' PS and St Vincent's PS) had waiting lists for a total of 46 catchment children, an overall reduction of 78%. This demonstrates the fluidity and movement of children throughout the session.

- All catchment children in the Secondary sector were placed following placing request decisions which created movement across the estate. There was no requirement for Local School Full in any of the 30 Secondary schools
- 3.1.4 As at 28 July 2023 a total of 5675 P1 pupil were registered for P1 across our Primary schools.
- 3.1.5 As at 28 July 2023 a total of 5794 pupils were registered for S1 across our 30 Secondary schools.

#### 3.2 Placing Requests

3.2.1 A total of 3928 Placing requests were received, of which 47% were Primary (P1) 53% were Secondary.(S1). The table below provides a summary of placing requests and outcomes.

3.2.2 Committee Services received a total of 545 appeals against placing request refusals for P1 And S1 in August 2023. Should spaces become available in schools with appeal prior to appeal date they are offered to appellants based on placing request ranking criteria, 36% of appeals received were able to be placed. Prior to appeal hearing.

#### 4 PROPOSALS FOR P1 AND S1 CAPPING FOR SESSION 2024/25

4.1 Taking into account the factors described in section 2 above, in line with the methodology contained within the national guidance the following details the proposals.

#### **P1 Primary School Capping**

4.2 Currently the statutory maximum class sizes are as follows:

Primary 1	maximum of 25 pupils
Primary 2 & 3	maximum of 30 pupils
Primary 4 to 7	maximum of 33 pupils
Composite Classes	maximum of 25 pupils

- 4.3 These restrictions mean that the number of children a school can accommodate will vary each year and is dependent on the age profile of enrolled children.
- 4.4 Of particular challenge is the determination of the maximum number of children that can be enrolled in P1 each year, relative to the overall number of classrooms available, the range of maximum class sizes of 25, 30 and 33 (noted above), and the number of P7 pupils leaving to go to secondary school. If P1 intakes are not capped, this can lead to the requirement to create additional classes where there is an absolute limit on the number of classrooms available. This can result in either the loss of general purpose classrooms that are extremely valuable for maximising the learning and teaching experience, or the need to provide additional temporary accommodation. In addition, the size of classes from P2 to P7 for the year of entry and in future will impact on the numbers of children that can be accommodated at P1. Due to the importance of effectively managing capacities of schools, training is provided for the panel members of Education Appeal Committees.
- 4.5 The Council places a priority on local children being accommodated in their local schools. Families can move areas within the city or move into the city between registration and August. Therefore, there may be times when Education Services has to review the cap to ensure that catchment children are accommodated in their local schools where this is operationally possible.
- 4.6 The proposed caps set out in appendix 1 of this report have been calculated based on the actual number of children registered at each school as of September 2023. As noted previously, the movement (either in or out) of even 1 child can affect the classification of a school and the number of children that can be accommodated in P1 at the start of the new term. For this reason, the caps proposed in appendix 1 are "notional" and may be subject to change dependent on the numbers of catchment children finally enrolled.
- 4.7 In line with the Council's policy of providing local schools for children, and the statutory duty to effectively and efficiently manage public resources, Education Services may also restrict P1 intakes in line with the national class size maxima (see 4.2). For example, if the P1 cap of a primary school is 54 (to ensure classroom availability) and there are 48 children from the catchment area. The Executive Director will use delegated authority to cap at 50 to create 2 classes of 25 pupils. This ensures that all catchment children are admitted, but also ensures effective management of public resources.
- 4.8 P1 capping in primary schools will mitigate against the loss of GP rooms and/or require the use of temporary accommodation in the short term and enable the Council to plan and manage the primary estate efficiently and effectively over the medium and long term.
- 4.9 In previous years the Cap for Gaelic Medium (GME) Primary schools at P1 has been set at 140 to manage numbers transitioning to Secondary, however this year caps have been set at the sustainable capacity for each of the 4 GME Primaries increasing the number of available spaces for P1 from 140 to 147.

#### **Secondary School S1 Capping**

4.10 Currently the statutory maximum class sizes for secondary schools are:

S1 and S2 33 pupils S3 to S6 30 pupils Practical Classes 20 pupils

S1 capping is an essential tool to manage capacities and to ensure that an effective timetable can be designed that provides all young people with a breadth of opportunities and learning experiences. A timetable can be limited by a number of factors such as staffing or facilities available to the school. The cap suggested take account of the limiting factors and has endeavoured to be set at the maximum sustainable level.

- 4.11 Appendix 2 to this report provides details of the Council's secondary schools proposed S1 capping limits for 2023/24.
- 4.12 The proposed caps set out in appendix 2 of this report have been calculated based on the actual number of children registered in P7 in Glasgow Primary Schools as of September 2023, and eligible to transfer to S1 in August 2024. as noted previously, the movement (either in or out) of even 1 child can affect the classification and timetabling of a Secondary school and the number of children that can be accommodated in S1 at the start of the new term. For this reason, the caps proposed in appendix 2 are "notional" and may be subject to change dependent on the numbers of catchment children transferring to S1 in their catchment secondary school.
