





INTRODUCTION & SUMMARY



Glasgow City Council ("the council") has an annual procurement spend of £754m. This spend is categorised across 57 commodities and is the combined purchasing power of two procurement teams; the Corporate Procurement Unit (CPU) which manages 52 commodities and £412m of the spend, the Health and Social Care Partnership (HSCP) Commissioning Team which manages 5 commodities and £342m of the spend.

The council continues to face significant financial and budget pressures. As a result, it must continually look to develop new innovative ways of working, that includes efficient and effective solutions to help reduce its spending and to increase its income. Procurement is seen as a key enabler in supporting the council's challenging budget reductions and strategic objectives. Our Procurement Teams continue to develop robust sourcing strategies and commercial models to help mitigate the financial impact of BREXIT and the ongoing pressures placed on supply chains as a result of geopolitical tensions and climate change.

We continue to focus and increase our activity in the following areas.

- Demand management analysis
- Detailed spend analysis and trends over the contract period
- Early market engagement to inform and shape the market
- The development of ambitious outcome focused specifications that take account of supply chain challenges and Person led care for our Social work Services
- The development of ambitious outcome focused specifications that take account of supply chain challenges
- Robust and comprehensive contract and supplier management to drive innovation, savings, deliver best value and high quality care


- Tracking market and cost indices to understand and challenge supplier price increases
- Embed Scottish Government Ethical commissioning and procurement principles

The council was once more recognised nationally via the GO Awards Scotland 2023/24, where we received two highly commended awards; one award was under the Social Value category and commended our Community Benefits Supplier Recognition Scheme and the other award was under the Sustainable Procurement category and this commended our Burrell Renaissance Project. These awards continue to evidence our teams hard work and drive for procurement excellence and build on our GO Awards success over the last 2-3 years.



2 SUMMARY OF REGULATED PROCUREMENT & SPEND



Section 18(2)(a) of the Procurement Reform (Scotland) Act 2014 requires organisations to include a summary of the regulated procurements that have been completed during the year covered by the report.

Regulated procurement refers to any procurement above £50,000 for goods and services, or £2,000,000 for works. A regulated procurement is completed when the award notice is published or where the procurement process otherwise comes to an end.

Regulated procurements can refer to new contracts and framework agreements, but also to mini- competitions, DPS ITT's and call offs from existing framework agreements.

The council completed 117 regulated and above procurement threshold procurements during the reporting period with a total award value of £809,211,226. Appendix 1 sets out a full list of the 117 procurements completed.

These procurements include projects supporting: Bulk Waste
Treatment, The Collection and Processing of Dry Mixed Recyclables,
Fresh Fruit and Vegetables, Business Growth Development
Framework Phase 3, Maintenance and Repair of Alarm Systems,
LED and Lighting column replacement, Purchase and Maintenance
of Articulated Units and Ejection Semi Trailers and other Council's
Business as Usual (BAU) Requirements.

The council also awarded its Civils and Infrastructure multi lot framework with an award value of over £400m.

Other contracts awarded out with BAU were for key procurements projects such as Glasgow City Region City Deal Initiative which included a number of public realm contracts.

The council also completed 62 non-regulated, non-social care related procurements with a total award value of £10,961,087 during the reporting period.

The council utilised multiple internal and external collaborative Frameworks to make new call offs for individual packages of social care. The total spend for the new call offs from existing council Social Care Frameworks was £8,489,000 and for social care Scotland Excel Frameworks was £1,410,000. The council also draw upon the COSLA National Care Home Contract with a total spend on older people's residential care of £86,698,000

During the reporting period there were instances where alternative methods of procurement were used in line with the regulations and the Council Standing Orders Relating to Contracts 2022 (e.g. where there is only one known supplier)


The Council currently has a commercial spend profile with 597 contracted suppliers. The table below provides further details, including the size of the organisation. 9% of suppliers are classed as unknown as the information is not available on the Scottish Information Procurment Hub.

CLIMATE CHANGE
AND
SUSTAINABLE
PROCUREMENT



As part of the council's journey towards becoming net zero carbon by 2030, public sector procurement is now viewed as a key partner and enabler as part of this transition. The council reports annually on the delivery of its Climate Plan and progress towards its net zero target, both internally to Committee and externally as part of its statutory requirements. An element of this demonstrates how its procurement policies and activities have contributed to carbon emissions reduction targets, contributed to climate change adaptation; and acted sustainably.

The council is continuing to develop and deliver against a number of sustainable related policies such as, Glasgow Climate Plan, Glasgow's Climate Adaptation Plan, the council's Fleet Strategy and Circular Economy Action Plan. These policies and plans are embedded within the Corporate Procurement Unit's strategic procurement process as are the Scottish Government's and Social Work Services sustainable tools which help to identify sustainable risks and opportunities.

Key Procurement Projects that have played a major role in to help support the council's sustainability agenda and will enhance the delivery outcomes of the council's Climate Plan. Please see an example of the key projects detailed below:

Study into Free Public Transport Pilot and Electric Shuttle Bus

This contract looks into the feasibility of increased bus usage and less vehicle trips which will result in a direct reduction of transport related carbon emissions.

Hot Beverage Consumables

The council continue to use triple certified coffee which has from Fairtrade, Rainforest Alliance and Soil Association. The successful supplier has provided a non-core option of its Peak and Wild coffee bean which is carbon positive.

Bulk Waste Treatment

This contract seeks to divert waste from landfill and promote recycling.

Utility Management Software

The provision of a utility monitoring service contributes to responsible consumption allowing the council to focus efforts on reducing greenhouse gas emissions from our highest emitters. With the inclusion of EV charge points in our data we can monitor the uptake of electric vehicles across the city as well as being able to monitor those sites within the council estate where EV charge points are being installed to support electrification of the council's fleet.

The Collection and Processing of Dry Mixed Recyclables (DMR)

The collection and processing of DMR will support the new deposit schemes and will help to meet our carbon-reduction targets, while creating a more sustainable and circular economy. The collection and processing of DMR contribute to greater recycling and a more sustainable city by minimising the populations demands on the primary resources and maximising the reuse, recycling and recovery of resources.

· Organic Waste - Food

This contract will enable and encourage all households in Glasgow to minimise waste arising and to repair, reuse and recycle. Reducing the carbon impact of managing this waste stream and to repair, reuse and recycle which will improve recycling performance.

Metal freestanding bins

This contract will help to reduce residual emissions through the purchase of blue recycling housings. The apertures on this housing should reduce the likelihood of unsuitable materials being deposited by the public which should increase the quality of material sent for recycling. Separate blue housings for material that can be recycled will contribute to greater recycling and a more sustainable city. Providing the public with access to recycling bins will help to increase recycling and reduce waste materials sent to landfill/ reduce residual emissions.

Tree Planting and associated works

The planting of trees and associated habitat creation supports many actions within the Climate Plan both directly and indirectly, increasing the potential for CO2 capture and so mitigating against climate change, providing positive outcomes by managing urban rainfall through canopy interception, managing the urban heat island shade and reducing localised wind and wind tunnels and by intercepting pollutants.

Organic Waste – Garden

Enable and encourage all households in Glasgow to minimise waste arisings and to repair reuse and recycle. Climate impact is reduced as garden waste is processed into compost.

Composting of garden waste puts variable nutrients back into the soil for growing of plants and vegetation. Processing garden material into compost will contribute to Glasgow's Net Zero carbon target by returning carbon back into soil for growing plants and vegetation.

Pollok Roundabout – Trial pits and Trenches

The full design project would replace an existing congested roundabout, thereby reducing vehicle emissions from vehicle idling and unnecessary longer diversions by avoiding the area. The full design project also includes additional active travel infrastructure, so the promotion of modal shift, would contribute to reduce transport related emissions.

Green Connectors, Tree Planting, Habitat Creation and Management Works 2024

The planting of trees and creation of associated habitat supports many actions within the Climate Action Plan both directly and indirectly supporting biodiversity increasing actual biomass (CO_2 Capture). Providing positive outcomes by managing urban rainfall through canopy interception managing the urban heat island shade and reducing localised wind and wind tunnels by intercepting pollutants.




The council use the measures available in the Public Contracts (Scotland) Regulations 2015 and the Procurement (Scotland) Regulations 2016 to ensure contractors comply with environmental, social, and labour laws when performing public contracts. These measures also allow the Council to request companies to replace their sub-contractors where they have breached any obligations in the fields of environmental, social, or labour law.

Procurement and Commissioning continue to access the Scottish Government's sustainable procurement tools and guidance within its strategic procurement process to help compliance with policy and legislation, including how to take an ethical approach in delivery of all relevant procurement activity. The CPU have delivered an online workshop to other public sector bodies on the use of the SG sustainable tools and outcomes achieved.

The council continues to access the Scottish Government's Prioritisation Tool to assist in the early stage of strategic planning and to bring a structured targeted approach to the assessment of sustainable risks and opportunities within our 57 spend categories. The prioritisation tool will be completed again in FY24/25, with support from the council's Sustainable Procurement Steering Group.

The council continues to adopt the Scottish Government's Single Procurement Document to help to mitigate against the risk of its tier one suppliers/contractors and their supply chains non-compliance with the Human Trafficking and Exploitation Act 2015 and Modern Slavery Act 2015.

To provide efficient and effective procurement for our stakeholders is a key objective of the council's Sustainable Procurement Strategy 2023 – 2027 (Procurement Strategy). To support this objective, the procurement teams consider collaborative frameworks in the first instance and will use the relevant framework if identified as the most appropriate route to market and proven to deliver best value for the council.


The council participated in 54 of the 63 available Scotland Excel Frameworks which is a participation level of 86% and covers a contractual spend of £55m. Other collaborative opportunities were reviewed on a project-by-project basis by working strategically and collectively with other public sector organisations and sharing work plans to identify areas of collaboration. This ongoing activity has resulted in the CPU utilising Frameworks implemented by the following procurement organisations:





DEMAND MANAGEMENT,
SAVINGS AND
ADDED VALUE



'Savings and Positive Outcomes' is a key element of the council's Sustainable Procurement Strategy 2023-2027. The categories of procurement savings and the process for calculation, approval, recording and reporting has been formalised and agreed by Corporate Finance and council senior managers. These calculations, categories and processes are also consistent with the 'Procurement Benefits Reporting Guidance issued by the Scottish Government.

The savings achieved from procurement activity in FY 23/24 can be broken down as follows:

Best Practice Indicator 1A Cash Savings	£6,748,061
Best Practice Indicator 1B Non-Cash Savings	£10,502,105
Total Savings	£17,250,166

These savings were delivered by the strategic procurement teams through a combination of tendering activity and contract management. These totals represent a significant increase on previous year's figures. While overall inflation has reduced over the last 12 months, cost drivers such as materials, labour, fuel, and shipping costs remain significantly higher than pre-pandemic levels.


This has meant that a considerable amount of the strategic procurement workload has continued to be focused on challenging and mitigating price increases requests. The 'Non-Cash' saving figure quoted above includes £507,184 of Cost Avoidance savings delivered by reducing price increase requests. The value of price increases incurred during the period was £16.7m.

To further support the strategic procurement teams focus on the commercial aspects of procurement, the CPU Commercial Team was formed in 2018.


During the period covered by this report, the Commercial Team has continued to deliver comprehensive spend and demand management analysis underneath a revised list of key targeted commodities: Post, Courier & Distribution; Vehicles; Refuse and Waste; Road Materials; Food & Water; Catering; Cleaning and Janitorial; Teaching Supplies; Aids; Coach Hire.

The Commercial and Strategic Teams have continued to identify and deliver savings across these commodities which contributed to the £17.2m saving figure listed above. In addition, the Commercial Team has continued to develop training, supporting documents and templates to ensure a consistent and more commercially focused approach is achievable within the Strategic Procurement and the Demand Management Processes.

Going into the next financial year, the commercial team will continue to support the strategic teams in identifying and securing savings under the targeted commodities wherever possible. Emphasis will continue be placed on non-contract spend within these commodities (including non-contract item spend with contracted suppliers) as this will likely be the best opportunity to deliver commercial improvements. The team will also continue to identify saving opportunities resulting from demand management, income generation markets and inflationary decreases.

The council was the first Local Authority to sign up to the Social Enterprise Buy Social Pledge, the buy social pledge is a values-led initiative bringing together private business, SME's academic institutions, and public sector bodies who are looking to make a commitment to bring social enterprises into their supply chain.

The Buy Social pledge signifies a transformative approach to doing business, where businesses become a catalysis for positive change in communities. The council has committed to the 5 buy social pledges.

The council has an annual spend of £8m with Social Enterprises in FY23/24.

The Social Enterprise Strategy identifies four thematic leads - Education, Economic Development, Procurement and Glasgow Social Enterprise Network (GSEN). Procurement has 10 actions with a number of these actions already being delivered. The strategy was established to help support and encourage opportunities for social enterprises to bid for and win procurement opportunities. These actions will be incorporated into the Council's new Community Wealth Building strategy, which is currently being developed.

The council continues to build upon its strong relationship with GSEN and shares its work plan to identify opportunities for Social Enterprises. The Council continues to share any quick quote opportunity with GSEN to ensure that local Social Enterprises can submit a response to the quotation. As part of our commitment to growing the sector, the Economic Development team has dedicated advisers who work with social enterprises, and also contribute to the funding of a post within GSEN to support its important work.

The Council has had early market engagement on a number of tender opportunities. The purpose of this process is to support and encourage suppliers to bid for tender opportunities covering, but not limited to; Provision of Pay as You Go Car Scheme, Civils and Infrastructure Framework, Glasgow Business Growth Development Framework Phase 3 and Bulk Waste Treatment. The Council also supported The Annual Meet the Buyer Event in 2024 which was hosted by the Supplier Development Programme.



engaging with our team of procurement and commissioning staff. The CPU were also guest speakers at the event.

The Council is committed to ensuring that all suppliers awarded business are paid within 30 days. Prompt payment clauses requiring a 30-day payment term are embedded within the Council's contractual terms and conditions. Suppliers must also apply the same terms and conditions to its sub-contractors which are delivering and supporting a Council contract. During the reporting period the Council paid 736,484 invoices with 95% of the invoices paid within agreed timescales.

The council became an accredited Real Living Wage employer during FY 23/24. Please see the link for further information on the accreditation - Glasgow City Council now accredited as a Living Wage employer - Glasgow City Council

The council has a significant commercial spend, and a strong influencing position to encourage our supply base to pay the Real Living wage. Due to this, all relevant regulated and non-regulated contracts have a minimum 5% weighting applied against Fair work First criteria.

The diagram details the number of suppliers appointed to a Framework /awarded a contract in FY 23/24 that either: pay the Real Living Wage; pay the Real Living Wage and are a member of the Scottish Business Pledge; or don't pay the Real Living Wage but are committed to other forms of fair work practice such as non-exploitive use of zero hour contracts, flexible working models or training.







REVIEW OF REGULATED
PROCUREMENT
COMPLIANCE



Section 17 of the Procurement Reform (Scotland) Act 2014 (Act) requires that regulated procurements are carried out in accordance with the organisation's Strategy so far as reasonably practical.

Section 18(2) states that an annual procurement report must include, at 18(2)(b), "a review of whether those procurements complied with the authority's Strategy" and, at 18(2)(c), "to the extent that any regulated procurements did not comply, a statement of how the authority intends to ensure that future regulated procurements do comply".


The Council's published its new Sustainable Procurement Strategy 2023-2027 in June 2023 and this strategy sets out how regulated procurement would be undertaken in compliance with the Act. This strategy supports the council's Strategic Plan 2022-2027 and will be continue as a key enabling strand within the ongoing reform and continuous improvement of the Council.

The strategy continues to build upon the achievements and benefits derived from the council's previous corporate procurement and commercial improvement strategy 2018-2022 with a view to:

- Using the power of procurement to deliver beneficial outcomes for the citizens of Glasgow, local businesses and the local area
- Support the council's key strategies, climate plan and net zero targets
- Make sure we comply with the new procurement regulations
- Continue to explore new technology and digital opportunities and utilise data and internal intelligence to shape and drive decisions
- Continue to promote the benefits of early procurement engagement and innovation

 Build capacity and skills within the council to improve commissioning and procurement activity and support procurement people of tomorrow

The strategy has six key strategic procurement objectives



The Strategy has 29 actions of which more than 50% of the actions have a sustainable theme. Two actions were due to be delivered by December 2023. The Table on Page 25 provides further details on the two actions delivered.

The council implemented the Scottish Government's new Document Exchange process, referenced as Doc X. This process continues to allow suppliers to submit electronic invoices free of charge and creates efficiencies for suppliers and the council. A new Blocked Invoice Project Group (Group), sponsored and led by the Head of Facilities Management, has been established with representation from CBS, CPU, Catering Facilities Management (CFM) and Service Areas to target the operational issues arising from the significant volume of blocked invoices. CBS has held training sessions with requisitioners from Services Areas to ensure best practice is followed when ordering and receipting orders via the council's purchasing system – PECOS. The CPU has developed several process changes to allow a higher level of invoice price blocks to be cleared in a timely manner. A significant proportion of the price blocks relate to orders that are impacted by volatile market conditions e.g. food, whereby alternative items are required depending on availability.	Dec 23

The council's procurement internet page has been updated to detail key strategic contracts that are on the workplan for the coming year, this will be updated on a regular basis. This will increase awareness on opportunities for suppliers and hopefully increase the number of tender bids received. The CPU communication plan (Plan) has been developed to ensure we use the most appropriate, efficient and effective communication channel for our stakeholders. The Plan is available for Service Areas to review, via the council's procurement intranet page, and includes the key mechanisms we utilise to engage with suppliers and increase their opportunity to gain business with the council. All regulated procurement in the council is undertaken in accordance with a legal and procedural framework which ensures that each procurement is compliant with the Strategy. Legal requirements are set out in the council Standing Orders Relating to Contracts 2022. Procedural requirements are set out in the Scottish Government Procurement Journey (for general procurement best practice) and the council's Corporate Procurement Manual (for Glasgow specific best practice).

In addition, the council's Procurement Toolkit provides templates and supporting documents which are aligned with these procedures.

The council continue to develop and maximise its Supply Chain Analysis and Risk (SCAR) report which was created during COVID and is issued to key stakeholders on a quarterly basis. This report focuses on key commodities that may be at risk due to areas such as Brexit, the Ukraine conflict, changes in global climate, labour shortages, geopolitical tensions and other supply chain issues. It covers key details such as Supply Chain Issues, Commercial Impact, long Term Impact, Service Area Impact and Mitigation Actions.

This allows full visibility of the potential challenges and risks the council may face and also provides the internal services areas, strategic partners, and senior management with visibility of the risks and mitigating actions being implemented to diminish the impact to the council. The report also provides details of price reductions, increases and cost avoidance under each commodity included within the report and covers areas of risk such as organized crime and monopolies.

Throughout the reporting period, the Council's regulated procurements continue to be monitored, on an ongoing basis, via the CPU's governance process. This monitoring process consisted of reviewing the key supporting documents which underpin the Council's legislative and procedural framework including; sourcing strategies, project plans, procedural documentation, evaluation scoring calculators and award approval reports.

The Strategy support Board is fully embedded and in place to offer further guidance and support at strategy development stage for high risk high value procurement exercises.

The Procurement management report is a crucial tool for overall governance and BAU activities as provides real time monitoring of procurement timelines, including late tenders, staff/team capacity and workload allocation.


These processes ensured that all regulated procurements were undertaken in compliance with the legal and procedural framework and, as a result, in compliance with the Strategy deliverables.

The reviews have also allowed the Council to identify the following potential improvement areas and build on previous strategy achievements.


The Council will:

- Continue to work with client teams on advance provision of work plans and strategies which will allow additional opportunities to deliver increased best value from the Council's regulated procurements.
- Promote sustainability, fair work practices and the importance of equality and equal treatment through procurement.
- Continue to target savings from all aspects of the strategic procurement process (tender, contract management, Purchase to Pay).
- Continue to look for collaborative opportunities within the public sector.
- → Ensure suppliers provide regular management information on the Council's usage of contracts.
- Promote the innovation partnership model as a mechanism and share relevant examples of new procurement solutions.

- Assess demand management opportunities at strategy development and contract management.
- Ensure SMEs are provided opportunities as standard within our quick quote process.
- Review Fair Work criteria and look to broaden the evaluation model and process for recording responses, and work with the Scottish Government on Fair Work First.
- Further promote the new Scottish Government sustainable online sustainable tools to wider key stakeholders.
- Ensure sustainability opportunities are acknowledged as part of strategy and specification development and incorporated into the evaluation process.
- Engage with new technology as part of the community benefits and contract and supplier management processes.
- Investigate solutions to encourage and enhance the prompt payment of sub- contractors and the impacted supply chain.



8 COMMUNITY BENEFIT SUMMARY



Section 18(2)(d) of the Procurement Reform (Scotland) Act 2014 states that it is mandatory for an annual procurement report to include "a summary of any community benefit (CB) requirements imposed as part of a regulated procurements that were fulfilled during the year covered by the report."

Section 25 of the Procurement Reform (Scotland) Act 2014 mandates that all contracting authorities "must consider whether to impose community benefit requirements as part of the procurement" when the estimated contract value is greater than or equal to £4,000,000.

Community benefits are a key objective of the Council's Strategy for 2018 to 2022 and the Council's own CB policy stipulates that community benefits must be considered for inclusion in all:

Goods and Services Contracts with an estimated value greater than

£50,000

Works Contracts with an estimated value greater than

£500,000

Robust processes have been developed to ensure that community benefits are considered for inclusion in all relevant contracts in line with the requirements of both the Procurement Reform (Scotland) Act 2014 and the council's own CB policy.

When initiating procurement activity, client departments are required to consider and highlight potential community benefits for inclusion where relevant. Procurement staff then engage with key stakeholders (including Community Planning, Economic Development and Education) and undertake market research and benchmarking activity to further explore potential opportunities and identify appropriate requirements for inclusion in the contract, or which will form part of

the CB evaluation criteria and menu. Delivery of agreed outcomes is monitored and reported internally on a quarterly basis using monitoring updates provided by suppliers. The entire process is overseen by a Community Benefits Steering Group comprised of key stakeholders from across the Council who are responsible for ensuring delivery of the policy, progressing further developments, and identifying and resolving any issues.

The Council continues to deploy Cenefits to support the monitoring and delivering of Community Benefit outcomes. Cenefits is a web and mobile application which makes it easy for Council staff and public sector buyers to manage, measure and release benefits in their contracts.

The system allows suppliers to upload evidence on their delivery of benefits for approval/rejection by the Council's Strategic Leads. The Community Benefit Officer, with support from the relevant category managers and procurement officers, manages and monitors the suppliers' Community Benefit obligations.

Community Benefits Theme - Community Engagement - Financial Support - Three edible playgrounds in Primary Schools - Sustainability Project

Supplier: Clear Channel

As part of their Community Benefit commitments Clear Channel had agreed to provide 100 Community Engagement points— Financial Donation outcomes. The Supplier had a clear vision of what they wanted to provide and working with their partners "Trees for Cities" promptly engaged with GCC Education department to set the wheels in motion.

The project was to create and build 3 Edible playgrounds within local primary schools to encourage schoolchildren to grow and eat vegetables, as well as integrating into the school curriculum. Edible Playgrounds offer a lively, engaging, multi-sensory way to teach children about growing and eating healthy food. Aside from the physical health benefits that eating well brings, learning in an outdoor environment combats Nature Deficit Disorder and has been shown to increase mental health by boosting mood, confidence and self-esteem.

Furthermore, allowing the children to connect with nature develops attentiveness and self-reliance in the pupils, leading to more sustainable behaviours in the long term. Trees for Cities are a UK based charity working at a national and international scale to improve lives by planting trees in cities.



They get involved with local communities to cultivate lasting change in their neighbourhoods – whether it's revitalising forgotten spaces, creating healthier environments or getting people excited about growing, foraging and eating healthy food.

The project was in 4 stages: identifying the schools, Supplier carrying out the surveys, discussing the plans with the nominated schools and then the build itself. The 3 schools nominated for the project were St Denis' Primary, G31 2RZ, Alexandra Parade Primary, G31 2TL and Anderston Primary, G3 8HY. The full project was completed in the Autumn of 2023.

In addition, due to the nature of the build, the supplier had to get admission to the schools at the weekend. This incurred a charge as permission had to be granted and the schools involved did not have the additional budget to cover the cost. The Supplier was more than happy to cover the cost which eased the pressure on the schools.

The Council Representative said

▲ A good community benefit for our schools and Thank you to Clear Channel for all their support in this fantastic project which will give these three schools a fantastic support as we work on the Glasgow Food Plan.

Community Benefit Theme – Skills and Training – Non-school Work Placement

Supplier: Covanburn Contract

As part of their Community Benefit commitments Covanburn agreed to provide a Work Experience Placement non-school outcome.

Covanburn had previously had experience working with The Bridges Programme and was very familiar with their work and wanted to work with them again in order to fulfill the outcome.

The Bridges Programmes is a specialist agency who supports the social, educational and economic integration of refugees, asylum seekers, migrants, and anyone for whom English is a second language, living in Glasgow. The Work Experience placement offered was a post in Administration and the offer was presented to The Bridges Programme to see if anyone would be willing to grab the opportunity.

The contact at The Bridges Programme had recommended an individual who had recently moved to Scotland from Hong Kong. The role was to shadow the Admin Office Manager and assist with Admin/Reception Duties. The placement began and was initially for 1 day a week for 6 weeks.

The individual was diligent and hardworking however she lacked confidence and had difficulty understanding the Scottish dialect. After a few weeks in the placement the supplier carried out telephone training with the individual.



Initially she was scared to answer the telephones but within a few weeks she was answering them within 2 rings.

The Supplier was fully supportive of her and were all on hand to help as sometimes the language barrier was tricky. At the end of the 6-week placement, the individual asked if she could continue the placement. The Supplier was delighted and was only too happy to honor her request as she had become an asset to the team.

Throughout her time spent in the placement her confidence had greatly increased so much so that she started to become interested in applying for jobs. The Supplier assisted the individual with updating her CV and she applied for a role she had spotted and felt confident enough to apply for.

She went for the job resulting in her application getting her an interview which resulted in her successfully being offered a full time job.

Community Benefit Theme – Skills and Training and Community Engagement – Financial Support – Community Investment - Supporting Young People to obtain CSCS Cards

Supplier: RJ McLeod

As part of their tender submission the Supplier had agreed to provide outcomes from the Skills and Training Theme and the Community Engagement Theme. Their outcomes included Work Experience and Community Engagement – Financial Donation. The Supplier has been a big supporter of Community Benefits and have always thought of new ways to do this. This outcome was no different.

Instead of providing separate Work Experience and donation to an organisation the supplier decided to fulfil the outcomes in another way. As they are in the construction industry they are aware of some of the difficulties for young people to get a step up to be able to work on a construction project. In order for anyone to work on a construction project a CSCS card must be obtained.

CSCS cards provide proof that individuals on construction sites have the appropriate training and qualifications for the job they are delivering. There is various level within the scheme depending on experience or role that the individual has. The supplier was looking to ensure that the young people received the entrance level card.

The Supplier had engaged with GCC Education department, the Strategic Lead for Community Engagement and the Community Benefits Officer to sought agreement for their proposal to combine both themes together in order that some young people can achieve a CSCS card.



All parties agreed that this was an excellent way to fulfil their Community Benefit commitments and the Supplier set about putting the plan in action.

Young People from Lourdes Secondary and St Thomas Aquinas Secondary – Glasgow took part in the proposal as they had shown an interest in the opportunity. There were 6 young people who took part altogether.

The Supplier provided taxis to pick up the pupils from the schools and took them to the Training Centre, the suppliers in-house Training Officer provided a full day of CSCS Card training to 6 young people which provided and delivered targeted training. The Suppliers in-house Trainer is fully qualified to deliver the training and to provide the necessary information in order to get them through. The young people had to sit an exam at the end of the training. The supplier not only covered the cost of the travel and also paid for all the NPORS exam and CSCS cards and paid for and provided study literature to the young people to assist with their training and learning. They also provided additional support where required.

The young people who took part were very engaging and made the most of the opportunity that they were given. All 6 young people were successful and passed the CSCS card final exam and have received their certificates. This will help open doors to employment on construction sites in the UK and giving them confidence.

Community Benefit Theme – Work placement (non-school) and Community Engagement (Hours) Supplier: Bridgeman Arts

Bridgeman Arts were able to offer the opportunity to Sophie Somerville to volunteer within our organisation over the course of three months to gain an experience of our community engagement work, artistic techniques, event management application and event delivery with the aim that she will be able to develop the skills to make a meaningful contribution to the community arts sector thus increasing the reach and potential of our area of work.

Sophie is 20 years old and has tried an academic course, but she felt that this was not suited to her learning style or main area of interest and so was seeking ways to explore her own capacity as a creative practitioner. we felt that our community benefits deliverables would be an ideal opportunity for her and also for ourselves to potentially develop a future staff member.

Sophie took up the opportunity on 9 occasions where she engaged in approximately 60 hours of work placement activity. this included: artwork techniques, technical and structural building work, organising, administrative work, event delivery, public facing stewarding work experience and event logistics and tech.



Sophie has provided a statement below:

66 My name is Sophie Somerville and I have been volunteering on a Bridgeman Arts programme. I approached the company in November 2023, but it was not until March 2024 that I was able to take up the opportunity. The Bridgeman Arts work during my programme was focused on parade arts development with a strong community arts focus and this work was an extension of my earlier experience in local community events so it was good to be involved in the making side of things with Bridgeman Arts.

Amongst other things, the placement opportunity gave me the chance to:

Develop some administrative knowledge and skills through cataloguing, keeping track and reporting on the arts materials and parts that we were designing. To learn about materials, specific tools and key components in costume, prop and public art manufacture to further develop my interest in this area of work.

This has been a very valuable experience for me, and I feel as though I can take a lot away from this - even some of the smaller things. I hope to continue to develop in this area and will continue to contribute to Bridgeman Arts work where I can.

Community Benefits Supplier Recognition Scheme

The Council Community Benefits Supplier recognition scheme has been recognized nationally at the GO Scotland Procurement Awards in October 2023 and is continuing to grow. The scheme continues to receive positive feedback from a significant number of suppliers and recipients of the community benefits. The scheme highlights and celebrates the varying stages of delivery of the agreed Community Benefit outcomes.

Suppliers are awarded certificates - Silver, Gold and Platinum status, dependent on the delivery status of their agreed Community Benefit outcomes. The award status criteria are outlined as follows:



Platinum Status

delivery of 100% of Community Benefit outcomes with additional voluntary benefits also delivered within the agreed timescales.



Gold Status

delivery of 100% of Community Benefit outcomes within the agreed timescales.



Silver Status

delivery of 50% of Community Benefit outcomes within the agreed timescales. The appropriate certificate is issued to suppliers post a monthly status review and is valid for a period of 12 months from the date of issue, where applicable, or from the contract expiration date.








A Voluntary Community Benefits Recognition Award certificate has recently been introduced. This will only be issued to suppliers which deliver voluntary benefits .



9 SUPPORTED BUSINESSES SUMMARY






The council's corporate procurement manual instructs that consideration must be given to the inclusion of supported businesses in all regulated procurements.


During the reporting period there were no regulated procurements awarded to supported businesses. The reason for this is that the goods, services or works associated with these procurements are not provided by existing supported businesses.

The Council does have existing agreements in place with Royal Strathclyde Blindcraft Industries (RSBi) for the provision of furniture and for the collection and disposal of confidential waste. The annual value of these contracts is £5.5m for FY23/24.




Future regulated procurements have been identified via the following means:

APPENDIX 2 - REQUIREMENTS OF THE ACT

(1) In this section -

- "small and medium enterprises" means businesses with not more than 250 employees,
- "third sector bodies" means organisations (other than bodies established under an enactment) that exist wholly or mainly to provide benefits for society or the environment.
- (2) In this section, references to the wellbeing of the authority's area include reducing inequality in the area. Procurement Reform (Scotland) Act 2014 asp 12 Part 2 Procurement strategy and annual report Section 15

15 Procurement Strategy

- (1) A contracting authority which expects to have significant procurement expenditure in the next financial year must, before the start of that year -
 - (a) prepare a procurement strategy setting out how the authority intends to carry out regulated procurements, or
 - (b) review its procurement strategy for the current financial year and make such revisions to it as the authority considers appropriate.
- (2) Subsection (3) applies where a contracting authority -
 - (a) has not, in relation to a financial year, prepared or reviewed a strategy under subsection (1), and
 - (b) becomes aware of the likelihood of having significant procurement expenditure during that year.
- (3) The contracting authority must, as soon as practicable after it becomes aware of the likelihood of having significant procurement expenditure-
 - (a) prepare a procurement strategy setting out how the authority intends to carry out regulated procurements, or
 - (b) review its most recent procurement strategy and make such revisions to it as the authority considers appropriate.
- (4) An authority has significant procurement expenditure in a year if the sum of the estimated values of the contracts to which its regulated procurements in that year relate is equal to or greater than £5,000,000.
- (5) The procurement strategy must, in particular -
 - (a) set out how the authority intends to ensure that its regulated procurements will
 - (i) contribute to the carrying out of its functions and the achievement of its purposes
 - (ii) deliver value for money, and

- (iii) be carried out in compliance with its duties under section 8,
- (b) include a statement of the authority's general policy on—
 - (i) the use of community benefit requirements,
 - (ii) consulting and engaging with those affected by its procurements,
 - (iii) the payment of a living wage to persons involved in producing, providing or constructing the subject matter of regulated procurements,
 - (iv) promoting compliance by contractors and sub-contractors with the Health and Safety at Work etc. Act 1974 (c.37) and any provision made under that Act, and
 - (v) the procurement of fairly and ethically traded goods and services,
- (c) include a statement of the authority's general policy on how it intends its approach to regulated procurements involving the provision of food to -
 - (i) improve the health, wellbeing and education of communities in the authority's area, and
 - (ii) promote the highest standards of animal welfare,
- (d) set out how the authority intends to ensure that, so far as reasonably practicable, the following payments are made no later than 30 days after the invoice (or similar claim) relating to the payment is presented -
 - (i) payments due by the authority to a contractor,
 - (ii) payments due by a contractor to a sub-contractor,
 - (iii) payments due by a sub-contractor to a sub-contractor,
 - (e) address such other matters as the Scottish Ministers may by order specify.
- (6) The Scottish Ministers may by order modify subsection (4) so as to substitute for the figure specified there for the time being such other figure as they consider appropriate.
- (7) In subsection (5)(b)(iii), a "living wage" means remuneration which is sufficient to ensure an acceptable standard of living.

APPENDIX 6 – GLOSSARY

Best Value

An economic assessment by the public sector as to whether a project represents value for money; the optimum combination of cost and quality to provide the required service.

Commercial

Area of spend that can be influenced by the procurement function.

Commodity

Taxonomy (classification) for the entire Council, to give the Council the ability to accurately describe the primary business activities of its suppliers the commodity approach presently used by the Council was defined back in 2006 and was reviewed and refined as part of the 2016 to 2018 Strategy. Commodity ownership, definitions and scope will continue to be developed as part of the Council's Corporate Procurement and Commercial Improvement Strategy 2018 to 2022.

Community Benefits

Community benefits are requirements which deliver wider benefits in addition to the core purpose of a contract. These can relate to social, economic and or environmental benefits.

Community Benefits Clauses

Community benefits clauses are requirements which deliver wider benefits in addition to the core purpose of a contract. These clauses can be used to build a range of social, economic, and environmental conditions into the delivery of Council contracts.

Flexible Framework Self-Assessment Tool (FFSAT)

This tool will help organisations assess where their current level of performance lies, and the actions required for improving their performance. The Scottish Government recommends that organisations carry out initial and periodic self-assessments against the FFSAT. This enables measurement against various aspects of sustainable procurement.

Public Contracts Scotland

The national advertising portal used to advertise all Scottish Government goods, services or works contract opportunities.

Regulated Procurement

Contracts above the EU contract threshold values where the relevant EU regulations apply (above £50,000 for goods and services contracts and above £2,000,000 for works contracts).

Small and Medium-sized Enterprises (SMEs)

Enterprises which employ fewer than 250 persons and which have an annual turnover not exceeding £50 million and/or an annual balance sheet total not exceeding £43 million.

Stakeholder

Any person or group who has a vested interest in the success of the procurement activity, i.e. either provides services to it, or receives services from it.

Supplier

An entity who supplies goods or services; often used synonymously with "vendor".

Supported Business

An organisation whose main aim is the social and professional integration of disabled or disadvantaged persons.

Sustainable Procurement

A process whereby organisations meet their needs for goods, services, works and utilities in a way that achieves value for money on a whole life basis and generates benefits, not only for the organisation but also to society, the economy, and the environment.

Third Sector

The part of an economy or society comprising non-governmental and non-profit-making organisations or associations

Work Plan

List of upcoming procurement activity including re-tenders, extensions, and new activity.
