**Details:**

Variation proposes to a) amend children and young persons access to include access to all public areas; b) amend the description of the premises to read "Mid market public house with large indoor area within a tenement building and with an outside seating area as well."; c) amend the layout of the premises to remove the fixed seating indoors and replace with alternative fixed seating, add a bin store and remove the smoking shelter; d) extend the beer garden area which will result in an increase to the capacity from 24 persons to 44 persons; e) incorporate an Outbuilding to seat 20 persons; f) add an external area to the front of the premises on Main Street to seat 12 persons; g) add an external area to the side of the premises to seat 16 persons and h) increase the overall external area capacity from 24 persons to 72 persons.
