## Prescribed Information - What does this mean for Landlords and Tenants in the Private Rented Sector?



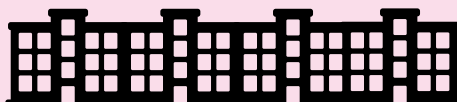
### What does this mean for Landlords?

From Monday 16 September 2019, the regulations will change the landlord registration process for new applications, renewal applications and amendments. The aim of this is to improve awareness of a landlord's responsibilities and in turn improve standards within the private rented sector, in order that homes rented to tenants are of good quality and are being managed professionally.

Landlords will be required to declare that their properties comply with the following standards where these are applicable:

- The tolerable and repairing standards
- Fire and carbon monoxide safety
- Gas and electrical safety

**The Private Landlord  
Registration (Information)  
(Scotland) Regulations  
2019 comes into force  
at 9am on Monday  
16 September 2019,  
introducing a more  
comprehensive, rigorous  
application process in  
order to raise awareness  
amongst landlords of  
their legal requirements.**







- Private water supplies
- Legionella risk assessment
- Energy performance certificates
- Buildings insurance and common repairs on tenement property
- HMO licences for Houses in Multiple Occupation.

The policy aims to:

- raise awareness about landlord responsibilities;
- identify where further advice or support may be required;
- ensure that local authorities are better informed and resourced to carry out the fit and proper person test; and
- improve confidence that anyone who is approved and entered onto the register is a suitable person to let houses.

**PLEASE NOTE**  
that the new regulations do not impose new duties upon landlords. As a registered landlord you should already be meeting these legal obligations.

## Universal Credit

### What do Landlord need to know about Universal Credit?

The Scottish Association of Landlords (SAL) in partnership with the Department for Work and Pensions (DWP), invites you to book to attend one of our roadshow information sessions all about universal credit.

Whether or not you currently have tenants in receipt of benefit, any tenant's circumstances can change and you may not be aware until they are already in the universal credit system.

Additionally many more tenants are on universal credit than were on housing benefit so more landlords are part of this system than ever before.

Having correct, up to date information before you are in this common situation for landlords may prove to be very useful in future.

The aims of these sessions are to:

- bust the myths about universal credit
- advise landlords in supporting tenant claims
- help landlords safeguard rental payments.

There will be an opportunity to ask questions of the DWP representatives as well as of SAL chief executive John Blackwood who will be your host for each event.
