What is your availability on the following dates (when I am currently available) so that I can propose a meeting with RFC at our Ibrox facility next week to discuss the Fanzone proposal (something I'll be having a lot of dialogue with them about between now & mid-March!) but also the longer term possibility of leasing the building to them to run their Community programme etc whilst presumably honouring some of our existing customers/users bookings?

I've already posed a few licensing questions to [REDACTED] and spoken to [REDACTED] at H&S (meeting him next week when he's on site at Bella to look over proposals) so they are in the loop re: the Fanzone prospect. I believe the complex was used as a Fanzone in 2014 for a Scotland game which took place at Ibrox while Hampden was out of commission so there is some precedent which is reassuring. Hopefully there's some documentation on that event which I can refer to. I'll catch up with [REDACTED] on Friday this week at the Sports Performance Day at Tollx to get his initial steer too but hoping to get a meeting with us all & RFC in asap.

Some initial discussions have recently been held with Rangers FC on the feasibility of developing a "Club Fan Village" concept on the pitch at Ibrox Community Complex.

Working collaboratively with Glasgow Life and other identified stakeholders, they are keen to grow and improve the fan match day experience. In view of this, it has been agreed that the next steps would be to convene a meeting with key operational staff to progress the necessary logistical arrangements for the fan village proposal, but at the same time consider a longer term approach, where the venue becomes instrumental in the delivery of Rangers community programme and where a long term lease or ultimately a community asset transfer would be considered advantageous for the sustainability of the established programme/s.
