I just wanted to say thank you for your time this week, it has been appreciated. I also wanted to let you know that we are attending the Ibrox and Cessnock Community Council meeting on Wednesday 25 July to present the Fanzone plans to the CC and to see if we can address the issues which have led to them raising the objection. As we have discussed this is only a trial and neither the CC nor Cllr [redacted] raised any objections to the application for the alcohol licence, therefore not providing any indication that there would be objections raised to the Public Entertainment Licence. However they are entitled to do so and we look forward to presenting our case to the Community Council and to the Hearing in due course. I have also attached an email which was sent to all four of our local councillors and each of the community councils within our locus, regarding the establishment of a Community Forum where we all meet quarterly to discuss issues pertinent to local residents and businesses. It would be great if Glasgow Life could also send a representative to these meetings.
