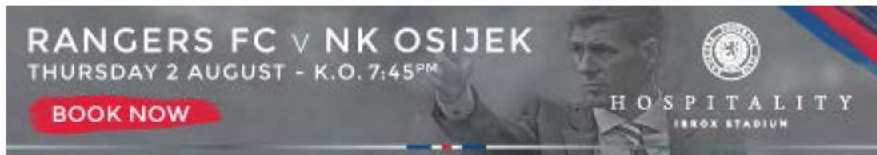

Hi [redacted] and thanks for that info

Happy with location & the attached inspection docs. Thursday 2<sup>nd</sup> anytime between 3pm-7pm would be best for us to move the container into place. We have a Rangers Football Camp in there all week 9am-3pm using the full pitch so best to avoid that period when it's busy and lots of children running around.

However, like you say, by that date we'll likely have had closure on whether the Community Council have held their Executive Meeting regarding whether their current objection to the Fanzone is still their position or not. If they don't withdraw their objection -or formally write something to GCC Licensing to that effect- then Glasgow Life will not be able to support the use of the venue for the Fanzone.

RFC's focus would then need to move to their future applications and trying to demonstrate that the Community Councils concerns have been listened to and actions have been put in place to combat those concerns, particularly on 2<sup>nd</sup> Aug & 11<sup>th</sup> August match days! Not much of what was raised at that meeting was directly linked to the new Fanzone proposals. It was more around what the residents experiences have been over the years on RFC match days & how they want to see more from RFC to combat anti-social behaviour & urinating in their streets/gardens etc. That dialogue and engagement with the community is clearly critical considering how political the landscape is that Glasgow Life work within. In hindsight, RFC would've been at the Community Council meetings far before now (some point prior to last seasons games ending) in order to get them on-board and genuinely believing that RFC are engaging and attempting to alleviate any of their concerns.

I'll give you a call as soon as I hear anything about the Community Council position which will likely be Mon/Tue so that we know if we're still on for Thu container move or not.
